City of Paisley Council Work Session Minutes of July 15, 2024

1. <u>Call to Order</u> The Council Work Session of the City of Paisley was held on July 15, 2024, at Paisley City Hall. Mayor Keith Harra called the meeting to order at 6:33 pm. Council members in attendance were Toni Bailie, Lora Mayea, and Wes Houston. Others in attendance were Rick Wann, Jeri Wann, Tyler and Kelli Gebaurer, Becky Marino, Camille Wallis, and Melissa Walton, recording minutes.

2. Business

- **2.1 PYRA** The proposed lease for the PYRA contract was reviewed and discussed amongst the PYRA members and the Council Members. After making some small changes to the proposed lease, Kelli Gebaurer will email the final copy to the Council for signatures.
- 2.2 Paisley Fire Department Dustin Withers explained the changes that OSHA is suggesting for all volunteer fire departments across the nation. If the changes are approved, it is believed that Lake County will lose their departments because they will not financially be able to meet the new expectations. There are multiple states that are threatening lawsuits. Dustin has also applied for a \$60,000 grant for next year for the fire department. This grant would cover lawn maintenance, debris removal, etc. The department is looking for an additional seasonal employee; Craig DeLarm cannot continue due to health reasons. Dustin explained that resources across the nation are exceptionally thin for fire department personnel. He plans to post the job opening around town and on social media.
- **2.3** Small City Allotment Grant Keith submitted the application for the grant for repairing city streets. He was contacted and told that if we applied for all the work needing done and were awarded the \$250,000, the city would be responsible to cover the remaining amount needed for all the repairs. Keith redid the paper work and resubmitted, removing some of the repairs for this season.
