City of Paisley Special Council Meeting Minutes of December 9, 2024

1. <u>Call to Order</u> The Special Council Meeting of the City of Paisley was held on December 9, 2024, at Paisley City Hall. Mayor Keith Harra called the meeting to order at 12:03 pm. Council members in attendance were Stu Burgess, Wes Houston, and Travis Garner. Others in attendance were Shelly Batty, and Melissa Walton, recording minutes.

2. Business

- 2.1 Shelly Batty Chamber Gala Ms. Batty spoke to Council about the Chamber Gala which will be held January 18, 2025, at 6 pm at the Lake County Fairgrounds. Tickets are \$75 per person. She wanted to make sure everyone on Council knew they are invited and asked if there were any awards Council would like to present that night. Along with flyers for the Gala, Ms. Batty left blank award nomination ballots for community members to fill out and return if interested. They discuss each type of award that would be given; senior first, community improvement, legacy, merchant of the year, best place to work, and have a blank spot for nominations.
- 2.2 Grant Administrator RFQ Two bids were received. Scoring sheets were given to each Councilor. Keith called the references for each bidder and relayed to other council members his conversations. There were no negative reviews. The score sheets each council were given allowed up to 10 points for similar experience; up to 10 points for ability to complete in a timely manner, up to 10 points for cost, up to 5 points for references, for a total of 35 points max per council member, 140 total max. Ducote Consulting received 135 points total, Carmen Tague received 122 points total. Stu Burgess moved to accept Ducote Consulting as the grant administrator for the EPA Grant, Keith Harra 2nd, MCU.
