

**City of Paisley**  
**Minutes of October 6, 2020**  
**Regular Meeting**

- 1.0 Call To Order/ Pledge of Allegiance** The Regular Council meeting of the City of Paisley was held on October 6, 2020 at Paisley City Hall. Mayor Ralph Paull called the meeting to order at 2:34 p.m. Council Members in attendance were Ralph Paull, Dale Roberts, Craig DeLarm and Krissy Funk. Others in attendance: Toni Bailie, Deanne Yoder and Melissa Walton, City Recorder.
- 2.0 Executive Session** None
- 3.0 Agenda & Consent Calendar** **Craig DeLarm moved, Dale Roberts 2nd, to approve the October 6, 2020 Agenda and the September 22, 2020 Meeting Minutes, MCU. Krissy Funk moved, Craig DeLarm 2<sup>nd</sup>, to approve the September Invoices, MCU.**
- 4.0 Business**
- 4.1 Travis Way, Water Superintendent** Travis was unable to attend but had stated to Ralph that everything was running fine. Ralph stated the Water System Survey assessment has been received from OHA. There are four points that need worked on and progress reported to OHA within 30 days. Ralph reiterated we need to find a generator for the system and also a back-up person for Travis. Krissy has spoke to Pierre Hoppe and plans to attend the next meeting of the Cemetery District.
- 4.2 Insurance for Home Owners on Water/Sewer Piping** Council discussed the homeowners insurance information received from LOC. If the City agrees, the insurance will pay a \$0.50 royalty to the City for each “product” sold or the City can opt to not receive a royalty payment. **Krissy Funk moved, Dale Roberts 2<sup>nd</sup>, to approve receiving the royalty if the City Attorney agrees to the proposal, MCU.**
- 4.3 Fundraiser** Council would like to buy three speed signs to place through-out town. Along with VIPs and the Mosquito Festival, Council is working on a fundraiser in order to purchase them.
- 4.4 Recycling** Ralph discussed using the old jail for a recycling building. Toni Bailie stated ICFC has been collecting bottles and cans already for fundraising which Ralph was unaware of and happy to hear about.
- 4.5 Traffic Court** The charter for the City enables Council to appoint a municipal judge. Melissa spoke to Dawn, the judge appointed in Burns. She said the Council will need to appoint a person who is already a member of the bar or a person willing to attend a two week course held each June in Reno. This course will need to be completed within one year of appointment. There will need to be

a contract for fees; she receives a flat monthly rate. The court is not a court of record, meaning there are no trials, everything is presented to the judge. And there are limits as to what that judge can hear; citations, tickets, no DUI's or drugs. As to a deputy she recommends talking to the Police Chief in Lakeview or the Oregon Chiefs Association. Craig was told he could get training as a constable; a constable can't arrest or transport anyone. Melissa will work on getting the cost of the schooling. Krissy knows of two people with prior law enforcement experience who have shown interest in the position.
