**REQUEST FOR QUOTE**

Quotes for the Vector Control, 2023 Project, addressed to the Owner, City of Paisley, Attention: Melissa Walton, will be received at City Hall, 705 Chewaucan Street, Paisley, OR 97636, until quote closing time, 5:00 p.m., local time, on the 4<sup>th</sup> day of April, 2023. Any quote received after the specified closing time will not be considered. Quotes will be publicly opened and read aloud during the 6:30 pm Paisley City Council Meeting that day.

The Project generally consists of the following:

- Commercial sprayer for the spraying/fogging of mosquitos within the city limits of Paisley. Must have the Public Health license or willing to obtain the certification required;
- Provide proof of certification and insurance;
- City has equipment available. If used, maintenance will be required;
- Spray once to twice weekly as necessary;
- Records or at a minimum, a copy of your records will be kept at City Hall.

Each quote is to be submitted in an envelope plainly marked "Vector Control, 2023 Project" and be delivered to the location specified above by or before the quote closing time. Quotes may also be emailed to [info@cityofpaisley.net](mailto:info@cityofpaisley.net) with the subject line marked "Vector Control, 2023 Project" and need to be received by or before the quote closing time.

In accordance with ORS 279C.365(h), each Bid shall contain a statement as to whether or not the Bidder is a "Resident Bidder" as defined by ORS 279A.120. Bid evaluation will include a percent increase added to the Bid submitted from out of state bidders from states which give preference to In-State Bidders, pursuant to federal requirements.

No Bidder may withdraw or modify a Bid after the hour set for the receipt of Bids and thereafter until the lapse of 70 days after the Bid opening.
