1.0 Call To Order/ Pledge of Allegiance

The Regular Council meeting of the City of Paisley was held on March 3, 2015 at Paisley City Hall. Mayor Dale Blair called the meeting to order at 7:00 p.m. Council Members in attendance were Dale Blair, Dick Mecham, Jo Hoppe, Ronne Lindsay and Robert Davis. Others in attendance; John Griffin Lake County Cemetery District, Nineteen members of the public and Emma Villagrana, City Recorder.

4.0 Public Input

4.1 Public Hearing Nuisance Ordinance. Mayor Blair presented the three items that the Council along with public input has been considering for the proposed Nuisance Ordinance. Much discussion from many members of the public about the Ordinance was heard with both positive and negative aspects addressed. Concern was raised about cars being included in item # 1 one as many citizens work on cars. Also, clarification on who makes final judgment on the complaint was asked to be clarified in a final draft. Emma Villagrana was instructed to incorporate the suggestions proposed and make additional changes as new suggestions come in to the City hall office. A proposed final draft will be published on the City Website, the City's bulletin board at the Post Office, and the Paisley Merc. Another Public Hearing will take place at the April 7th Regular Meeting during public comment to further discuss the draft Ordinance.

presented and to note no financial penalty for March 1st and 2nd. Dick Meham 2nd. MCU

5.4 **Community Center Repairs.** Balance sheets for the Community Center Repairs were reviewed by Council. A quote for an annual maintenance on the Floors was reviewed. Mary Lou Sanchez will ask VIPS about interest in donating designated floor money towards this project. Jo Hoppe asked about the little room heaters. Emma Villagrana reported that they are working. Attention was drawn to the recent repairs done by Duane Young on the Transitions in the Bathroom and Kitchen. This will make the areas safer and hopefully help the existing linoleum last longer.
